Terms & Conditions Agreement:

A non-refundable deposit of €40 for Dogs and €30 for Cats is required to make a Pet Hotel Booking. For peak season bookings (June 1st - August 31st, December 22nd to January 2nd & 1stApril -30th April), deposits for these periods are 50% of the booking cost. Peak rates are also applicable.

Payment for the full boarding term is required on the day of drop-off of your pet. As of December 1st 2016, all peak period bookings must be paid in full **21 days** before arrival. Sunday we are only open 9am – 1pm

Pets will only be released to the Primary Owner, Secondary Owner or Emergency contact unless otherwise stated by the Primary owner in writing. There is no refund or credit for early holiday returns. All board rates are charged on a calendar day basis and the full period booked will be charged. The Pet Owner agrees to pay the rate in effect on the date pet is checked into DSPCA Pet Boarding or Day Care.

The Pet Owner further agrees to pay all costs and charges for special services requested and any emergency veterinary costs for their pet during the time said pet is in the care of DSPCA. You must provide proof that your pet's vaccinations are up-to-date. No animal will be accepted unless these vaccinations are up-to-date. Kennel Cough (dogs) must be administered with the yearly boosters. Please remember your pet cannot come into our facility for **14 days** after the vaccination as it is live and can put others at risk.

The Pet's own food must be supplied. If your Pet's food has been forgotten, dry food can be purchased from our shop. Medications must be in their original, labelled container with vet sticker attached or it **will NOT** be administered.

Late Collection from day care after 7pm will incur a €10 charge. Boarding: Check-in is from 11am until 5pm Monday to Friday and 11am to 4pm Saturday, Sunday and Bank Holidays (early check-in between 9am and 11am is available on request for an additional €10). Check-out is by 10am on the day of departure. After 10am, you will incur a full charge for the day. We close daily between 1pm and 2pm.

The pet owner acknowledges that their dog may be mixing with other dogs unless otherwise stated and that playing with other dogs can sometimes result in wounds, loss of hair, death etc. Dogs may become dirty as a result of socialising.

If your pet becomes ill or if the state of the animal's health requires professional attention, the DSPCA in its sole discretion, may engage the services of a veterinarian, administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the owner. DSPCA Pet Boarding staff will make a reasonable attempt to contact Owner prior to engaging such services when possible. The Pet Owner agrees to give permission to the DSPCA Pet Boarding to allow personal information regarding Owner and Pet to be given to or received from a duly licensed veterinarian. The Dublin SPCA cannot be held responsible for injury, illness or sudden death arising during your dog or cat's time in boarding. Pets may go home more tired than normal due to an increase in exercise received in our care. Booking and Delivery of pet to DSPCA Pet Boarding facilities constitutes acceptance of the terms and conditions advertised.
